BILL FOR THE NATIONAL SPORTS COMMISSION (AMENDMENT) ACT NO. OF 2024

Explanatory Note

This Bill amends the National Sports Commission Act No. 14 of 2014 ("the Act").

The National Sports Commission ("the Commission") is currently composed of 4 members. Given that the Director General of the Ministry of Youth and Sports is currently a member and Chairperson of the Commission, this Bill removes the Director of the Department of Youth and Sports as a member of the Commission.

Furthermore, the current composition of the Commission restricts the ability of the Commission to make informed decisions necessary in performing its functions. Therefore, in order for the Commission to be able to make more informed decisions, the Bill includes the following Director Generals as members of the Commission:

- (a) the Director General of the Ministry of Education; and
- (b) the Director General of the Ministry of Health; and
- (c) the Director General of the Ministry of Internal Affairs.

The Bill further makes the following changes to raise the standards of the Commission to be recognised as the superior national body responsible to deal with national and international sports matters relating to Vanuatu:

- (a) change the secretariat of the Commission from the Director of the Department of Youth and Sports to a formalized Chief Executive Officer position; and
- (b) increase the number of times in which the Commission may meet from 2 to 8 meetings; and
- (c) increase the sitting allowance of the Commission members from Vt5000 to Vt10,000 per sitting; and
- (d) change the name of the National Sports Commission to the "National Sports Authority".

1 Amendment
