BILL FOR THE STATUTE LAW (MISCELLANEOUS PROVISIONS) ACT NO. OF 2024

Explanatory Note

The Bill provides for the amendments to the following Acts:

- (a) Consolidation of the French and English Texts of the Laws of Vanuatu Act [CAP 295];

Item 1 amends the Consolidation of the French and English Texts of the Laws of Vanuatu Act [CAP 295].

This amendment provides that the Attorney General is to appoint the French Consolidator and the English Consolidator to consolidate the French and English texts of the Laws of Vanuatu.

Item 2 amends the **Designs Act No. 3 of 2003**.

This amendment changes the reference of Registrar to Registrar General. The Registrar General is responsible for the registration for designs and is appointed under the Vanuatu Intellectual Property Office Act No. of 2024.

Item 3 amends the Electoral Act No. 16 of 2023.

This amendment provides that the term "electoral officials" used in the Act includes the Chairperson and the members of the Electoral Commission.

Item 4 amends the Family Protection Act No. 28 of 2008.

This amendment corrects the French text of the Act only to correspond to the English text of the Act.

Item 5 amends the Financial Dealers Licensing Act [CAP 70].

This amendment corrects the French text of the Act only to correspond to the English text of the Act.

Item 6 amends the Import Duties (Consolidation) Act [CAP 91].

This amendment corrects errors in the Act. The Act provides for exemptions to excise tax which are not provided for under the Excise Act [CAP 290]. This amendment repeals these errors.

Item 7 amends the Marriage Act [CAP 60].

This amendment clarifies that marriage is the union of a male and female.

Item 8 amends the Office of the Attorney General Act [CAP 242].

This amendment reinstates the Financial Intelligence Unit ("the FIU") as a Unit under the Office of the Attorney General. This amendment further removes the elected members of Parliament comprising the Government (Government back-benchers) as clients of the Attorney General.

Item 9 amends the Ombudsman Act [CAP 252]

This amendment corrects the French text of the Act only to correspond to the English text of the Act.

Item 10 amends the Patents Act No. 2 of 2003.

This amendment changes the reference of Registrar to Registrar General. The Registrar General is responsible for the registration for patents and is appointed under the Vanuatu Intellectual Property Office Act No. of 2024.

Item 11 amends the Police Act [CAP 105].

This amendment empowers the Commissioner of Police to designate certain officers of the police force as detectives. The purpose of this amendment is to allow the Vanuatu Police Force to recognise certain police officers who have highly developed skills, competence, and training as criminal investigators.

Item 12 amends the Political Parties Registration Act No. 15 of 2023.

This amendment provides for a screening committee that is responsible for the screening of all applications for the registration of political parties. This committee consists of the Principal Electoral Officers, a representative of the Attorney General and a representative of the Vanuatu Financial Services Commission.

This amendment further provides that a custom movement intending to field a candidate to contest an election may do so without having to register as a political party. However, that custom movement must not field candidates in more than 1 constituency.

Lastly the amendment removes the requirement for political parties to submit annual financial reports to the Commission as grounds for deregistering that political party. Political parties will now be left to the Financial Intelligence Unit to scrutinize the funds of its members.

Item 13 amends the **Protection of Traditional Knowledge and Expressions of Culture Act No. 21 of 2019.**

This amendment changes the reference of Registrar to Registrar General. The Registrar General is responsible for registration under this Act and is be appointed under the Vanuatu Intellectual Property Office Act No. of 2024.

Item 14 amends the Trade Unions Act [CAP 161].

This amendment provides that the Commissioner of the Vanuatu Financial Service Commission is responsible for registering trade unions. This amendment is necessary as the Act is not clear on who is responsible for registering trade unions.

Item 15 amends the Trademarks Act No. 1 of 2003.

This amendment changes the reference of Registrar to Registrar General. The Registrar General is responsible for the registration of Trademarks and is appointed under the Vanuatu Intellectual Property Office Act No. of 2024.

Item 16 amends the Vanuatu Copyright Management Society Act No. 46 of 2017.

This amendment changes the reference of Registrar to Registrar General. The Registrar General is responsible for the registration under this Act and is appointed under the Vanuatu Intellectual Property Office Act No. of 2024.

- (1) This Act commences on the day on which it is published in the Gazette.
- (2) Amendments in Item 5 relating to the Financial Dealers Licensing Act [CAP 70], commence on the date on which the Financial Dealers Licensing (Amendment) Act No. 5 of 2024 commences.
- (3) Amendments in Items 2,10,13,15 and 16 commence on the date on which the Vanuatu Intellectual Property Office Act No. of 2024 commences.
