The closing date for submissions is at the close of business 4:30 pm on the Wednesday 23rd February, 2022. Submission Fact Sheet

The evidences are compiled under Parliamentary privileges. This means no one is liable to any civil or criminal proceedings concerning the information disclosed to the Committee for the purpose of the hearing. If your submission contains information you do not wish to be made public, please be sure to clearly mark it 'CONFIDENTIAL'. The Committee will consider all requests for confidentiality, but is not obliged to grant a submission confidential status if it determines that it is not in the public interest to do so.

Any submission should state whether it is from an individual or organization. State clearly in you submission if you or your organization intends to appear before the Committee. When writing your submission, be truthful and provide information that supports what you are saying (make sure your facts are right); Use bullet points to help make your points clear; number your pages to help the Committee in referring to the submission during oral evidence.

COMMITTEE FUNCTIONS

The Committee is established under *Standing Order 62 and 63*; a motion made under *Article 23 of the Constitution*, together with the following duties and functions:

- a) To inquire and examine matters related to foreign and domestic investments;
- b) To inquire into and examine matters related to the regulation of economic activities;
- c) To inquire into and examine matters related to foreign and domestic commerce;
- d) To inquire into and examine matters related to land use, public-owned corporation with an economic or commercial vocation and economic infrastructures;
- e) To report to Parliament as to the results of inquiry or review on such matters subject to the inquiry or review;
- f) To recommend as to what measures are to be taken under procedural and reform changes in such matters subject to the inquiry or review;
- g) To review important new policy initiatives relating to foreign affairs and Trade and give its opinion to the Government before their implementation;
- h) To scrutinize the qualifications, experience, and suitability of proposed Vanuatu's diplomatic and trade representatives overseas prior to their appointment;
- i) To enquire into the issue concerning Vanuatu's Diplomatic Passport and the alleged sale of the same;
- To enquire into the management and operation of the Ministry of Foreign Affairs, the Ministry of Trade and Commerce, the Vanuatu's Overseas Missions, the Department of Trade and Department of Foreign Affairs;
- k) To summon Government officials and public to assist it in its work;
- l) To consider, inquire into and examine Government bills and report to Parliament;
- m) To consider and examine annual reports of Government Ministries and report to Parliament;
- n) To receive briefings or initiate inquiries onto matters related to the subject areas of the Committee;
- o) To consider and examine any Order made by a Minister under an enactment related to the subject areas of the Committee;
- p) To consider any matter, business and question as may be referred by Parliament from time to time;
- q) Include such other duties as assigned to the Committee by the Standing Orders approved by Parliament.
